CLIMATE CHANGE POLICY

As IC Enterra Renewable Energy, we place special importance on combating global climate change and its effects, as these directly impact our operations in the sectors in which we operate. In line with this approach, it is among our priorities to take an active role in the fight against climate change by being aware of the necessary steps to measure and manage climate-related risks, as well as the opportunities that may arise, and to contribute to Türkiye's transition toward a low-carbon economy.

As IC Enterra Renewable Energy, through this Climate Change Policy, we adopt the following principles as a general framework:

- To take climate change mitigation and adaptation into consideration across all areas of activity and operations, including IC Enterra Renewable Energy and its affiliated companies,
- To address climate change at all organizational levels, including the Board of Directors, and to follow a multidisciplinary approach through the participation of relevant Group Companies and working groups,
- To measure risks arising from climate change and prepare strategic plans to mitigate such risks and ensure their implementation,
- To carry out activities aimed at reducing emissions throughout the entire value chain. In this context, to implement energy efficiency practices and projects, to engage in activities that increase the share of renewable energy sources in the total energy supply, and to calculate greenhouse gas emissions in line with international standards and approaches,
- To set short-, medium-, and long-term targets for the reduction of greenhouse gas emissions, and to share our performance and climate-related risks and opportunities with all stakeholders in accordance with the principles of transparency and accountability in line with international standards,
- To actively contribute to the United Nations Sustainable Development Goals (SDGs) focused on combating climate change,
- To take an active role in the fight against climate change in Türkiye and around the world by establishing collaborations and partnerships—primarily with national and international public institutions and organizations, as well as with private sector companies, academics, and non-governmental organizations—and to support related projects,
- To raise awareness among our suppliers within our sphere of influence regarding the fight against climate change and to develop joint projects in this field.
